

Directions to Larwood Park

- 1. From Salem, travel 13.6 miles East on Highway 22. 2. Take the second Stayton exit, toward Santiam / Sublimity.
- 3. Turn right onto Cascade Highway (which becomes North 1st Ave. in Stayton). 4. North 1st Ave. becomes Stayton-Scio Road. (Stay on this road for about 3 miles after exiting Highway 22 don't worry about the name changes).
- 5. Turn left on Cole School road and travel 3.2 miles.6. Turn right onto Ridge drive and take a very slight left onto Richardsons Gap road.
- 7. Travel on RichardsonsGap road for 4.4 miles.8. Turn left onto LarwoodDrive and travel 4.7 miles.

Book of Mormon Evidences Class

Recently, I was invited to a local ward of the LDS church for a presentation on the evidences of the Book of Mormon. The friend who had invited me is the 1st Counselor to the Bishopric, and wellacquainted with many of the Restoration beliefs. I was unable to attend, but afterwards I asked my friend for his opinion. He was very excited and positively endorsed the class. I was able to contact the teacher of the class, Dr. Loyd Colvin, and speak with him at length. We acknowledged the significant differences that continue to exist between the LDS church and the Restored Church of Christ, but we also spoke lovingly of a most powerful bond: Jesus Christ, and the witness of Him made by the Book of Mormon. After speaking with my counselors, I invited Dr. Colvin to give the class to the Saints of the Restoration, and shared with him my expectations. He agreed with some excitement. The class will be at 7:00 p.m. at the church on August 9th. Other Sunday evening classes will be postponed. The class is a PowerPoint presentation and will last about 1 hour and 15 minutes. Dr. Colvin will not be teaching about the LDS church, or discussing the differences between our beliefs and theirs. He will focus only on the Book of Mormon: the archeology, linguistics, animals, and evidence that it is a divine work and not the invention of any man. I hope every Saint will attend. Missions, by Brian Herren

It has been a blessing to me to be able to send scriptures and church history books to Africa, South America, Australia, Asia, Israel, Europe and throughout America. Several relationships have been developed & I maintain correspondence with several in gospel bonds. In the Spring of this year, a man named Manuel emailed me from England. He had a great desire to study the Book of Mormon and felt that he had been told of God that the Book was inspired by the Holy Ghost. Once he received a Book of Mormon his thirst continued, and he requested a Doctrine & Covenants, as he felt the Lord had led him to this church & he was desirous to join. I began to search for an elder near Brother Manuel & found none. I mailed him a Doctrine & Covenants, Inspired Version of the Bible, and a church history book. Brother Manuel continues to study diligently, though his English is imperfect (he was raised in Portugal & later moved to Bracknell, England). He writes often, and demonstrates an unusual comprehension of the Gospel of Christ and the laws by which God governs His Church. Brother Manuel remains desirous of baptism, so I suggested we both pray about the matter for a time. After prayer & fasting, I received my answer: the Spirit said, "Go". I emailed him and told him that I would travel to Bracknell and baptize him and any others of a like mind if it was God's will. He continued to pray & recently emailed me back. He feels that he has had a confirmation of my answer by way of the Holy Spirit, but was led to begin a Restoration prayer/study group. He will gather all of a like mind and they will study the Gospel, the Restoration, church history, the priesthood, etc. for 12 months. He has invited me to plan my visit sometime in the Fall of 2010, Lord willing, when as many as have been prepared might receive baptism by one having authority (2 of us will travel), and perhaps a mission or branch be established. I will see how the Lord directs, but I ask for your frequent prayers. Many things can change between now & then. Please pray for us all.

Answer to Prayer By Bill and Nancy Curtis

Have you ever been accused of something that you didn't do? Having an accusation made against you is bad enough by itself, but when you don't have much recourse against the charges and it could mean a prison sentence, it is a very lonely and depressing emotion to deal with. It's there when you fall asleep at night and with you when you wake up. It's a nightmare that doesn't go away. This is what happened to our grandson, Bill.

Since early in April, he was being held in the Alexandria, LA county jail on charges that he assaulted another person. He flatly denied it but nevertheless, he was being held as one of three men who had committed this crime.

We asked for prayers on his behalf at prayer service and told Bill that we had shared our concerns with our church friends. We also were in contact on a regular basis with his court appointed attorney who went by the name "Mr. Billy". Every time we faxed or called the attorney's office, we were always met with very polite, caring people. If Mr. Billy wasn't in, he still always returned our phone calls when he returned to his office. We were told that he would get to the bottom of the matter and we felt personally that he would do all that there could be done for Bill.

On Wednesday, June 17th at 4:30 in the evening, we received a call from Mr. Billy and he told us that the District Attorney had dropped all charges against Bill and he would be free to go home as soon as they could get the paper work done. What a huge answer to prayer! (Blessing #1) He thought it might be about 48 hours. He told us that we could call Bill and let him know. I looked up the phone numbers for the county jail and did not realize that there are three detention centers and I called the number for #1 when I really needed #3. I dialed the number listed for the warden and a woman answered. I told her what the attorney had just related to us and asked her if there was some way she could get word to Bill and ask him to his grandmother. She told me that she was in facility #1 but she could still get word to him. I thanked her and waited. Fifteen minutes later Bill called. Since his grandfather had been sick, he was afraid that I had bad news for him. I asked him what the best news would be that he would like to hear. He said "that the charges have been dropped". His grandfather and I both said at once "your charges have been dropped". He was speechless and couldn't believe what he was hearing. He hollered out to other men standing nearby, "my charges have been dropped, I'm going home". The others were really happy for him. He said he needed to go for a walk and let this news process and he would call back later in the evening. I called the phone number again for the warden's office wanting to thank the secretary for contacting him so quickly and when no one answered I looked at the clock and realized that it was 6:45 pm their time and the office closes at 5 pm. Somehow, she had been available after the office closed. (Blessing #2)

On Thursday morning at 7:30 am our time, we received a call from Federal Agent Denise who informed us that Bill was to be released within the hour.

We told her that we had to make plane reservations and could she hold him a little longer. She said it was against the law for her to hold him but understanding the situation she could occupy herself with some other matters first. She gave me her personal cell phone number (Blessing #3). We began to think through all the details that would be necessary to get Bill home. The first thing we realized was he had no personal ID on him that would allow him to board an airplane. I called Denise and she said she had not thought of that but would make a copy of some ID that hopefully would take care of it. We then realized that he didn't have any money for food on the trip home. We had sent Bill a money order on Monday for \$50 so I called the jail again (once again calling the wrong phone number) and asked if that money had possibly been placed on his books yet. The woman I spoke with told me I had the wrong facility but said she could still look it up. She said the money had just been recorded on his books and would be available to him in check form when he left. (Blessing #4) I called Denise again and told her about the money but didn't know how he could possibly get it cashed. She said she would take him to her personal bank so he could get it cashed. (Blessing #5) As we talked at different times during the day she related to us that she had taken Bill and someone else to court that morning and as she walked in she was told that there would be no court for him, his charges were dropped and he was to be released. She said that had never happened to her before. (Blessing #6)

Then it was time to make plane reservations. I called American Airlines because they had a flight with only one stop, and spoke to a woman about the immediate situation. She asked if he would have luggage and I told her he would only have the clothes on his back. I explained what had happened and she said "well, I'm going to get him a window seat all the way home", and she did. (*Blessing #7*) I called Denise back explaining the options of two different times to fly out and since she wasn't sure about the earliest flight, we took the later one because she would be taking him to the airport. We asked if Bill could call us before he took off and she said she would see that it was done.

We wanted to give Bill a calling card number so he would be able to reach us at any time during his trip. Agent Denise took him to her bank, then the airport where she spent three hours with him talking over lunch and getting him through security. (Blessing #8) She had Bill call us on her personal cell phone and it was still unbelievable to him that he was on his way home. He arrived in Portland at 11:45 pm that night and several family members were there to greet him. It was such a happy time of relief, gratitude and thankfulness to the Lord for his bounty to us. (Blessing #9)

The following morning I called Denise to thank her once again for her kindness to Bill and her help on so many different levels. She said she had wondered if he got home alright and said she had prayed for him. (Blessing #10) I thanked her for her concern and for seeking the Lord on his behalf.


